5. We shall work out the requirements of essential machinery, equipment and tools required for different courses. We shall ensure their relevance and optimal utilization. We shall jointly workout the strategy for repairs and maintenance of institutional equipment sharing of equipment and resumes and replacement of absolved equipment of the institute and modernizing their laboratories and workshops. We shall also examine the possibility of giving certain equipment models etc. to the institutes for making the practical training more meaningful.
 6. We shall workout the infrastructural requirements of the institutes and possibility of providing financial assistance from industries side to the extent possible for developing institutional libraries laboratories play grounds etc.
 7. We shall jointly evolve a programmer for professional development and career advancement of faculty in the industry, providing guest faculty to institutes and drawing faculty members from institutes to give lectures to workers etc.
 8. We work out a programme for bringing competitiveness in the work by amazing skill competitions debates on technical issues etc. We shall promote periodic technical exhibitions to encourage innovations.
 9. We shall arrange for industrial visits of trainees in the vicinity and holidays and shall ensure that they are exposed to world of work.
 10. We shall jointly arrange a programme for periodical evaluation of students as regards skills and knowledge. Arrangements shall also be made for providing communication skills and vocational guidance to the students.
 11. We shall jointly prepare a scheme of execution of industrial jobs by institutes under production oriented training scheme part of earning shall be distributed among student to promote the concept "Train while learn" trainees will also be assigned aeration industrial problems to promote innovation.
 12. Though this MOU has been entered for one-to interaction both the institute and industry may act as interface for a group of industries on one side and group of institute on other side to promote the idea of collaborative model on a large.
